Therefore, the Company is not required to adjust the exercise price and the exercise ratio of the Warrants to Purchase the Ordinary Shares of the Company no.3 (TRITN-W3) as prescribed in the Rights and Duties of the Issuer and Holders of the Warrants to Purchase Ordinary Shares of the Company no.3 (TRITN-W3).
